



## Entry Guidelines and Challenge Rules

**All Entries Must:** use the oval center of the cameo panel and it must remain intact, including the two printed ovals between the floral cameo and the background. The center panel design can be added to or embellished but must remain recognizable in color and design. This will be the one design element that unifies the collection.

**All Entries Must:** use additional fabrics at the discretion of the quiltmaker. It is not required to use the background with roses that surrounds the cameo. It is not required to use additional Kaffe Fassett fabrics. Two suggested green fabrics are included in this kit but you are not required to use them.

**All Entries Must:** use appliqué made solely of shapes that can be cut with the Sue Pelland Designs Leaves Galore® templates and/or the Hearts & More® templates. A few sample shapes made with Leaves Galore Petite and Hearts & More Template A are shown on the back of this application. Participants may use these shapes and may create other shapes that can be cut solely with the templates. Participants may be asked to show how to cut the shape with the template if it is not obvious to the judges how the shape was made.

**All Entries Must:** use some form of appliqué. Any method of appliqué is acceptable. Additional techniques such as piecing and embellishments may be used.


**All Entries Must:** be layered with three layers: top, batting and backing. Quilts must be quilted and bound. Finished quilt including binding must measure 30" x 30"

**All Entries Must:** be accompanied by a completed Official Entry Form (included in this packet). The registration fee is included in your purchase of this challenge packet.

**All Entries Must:** include up to three photographs of your quilt with the entry form. One photo must be the quilt top in full. Two additional photos may be submitted to show detail of the quilt top.

**All Entries Must: be received by January 31, 2018**

Only entry forms and photographs received by January 31, 2018  
will be considered for judging.  
Initial judging by the submitted photographs will be completed and  
finalists notified by February 15, 2018

You may be asked to send your quilt for final judging with shipping and  
insurance at your expense. Please do not send your quilt unless requested  
by the judging committee.
